Thanks to defense and aerospace giant Lockheed Martin for stopping its donations to the Boy Scouts of America over the organization's ban on gays serving as adult leaders.

In early December, petition-collectors gathered 116,284 signatures to put marriage equality on the November 2014 ballot, exactly the number of signatures necessary. Now people are collecting enough extra signatures to guarantee a sufficient number of signatures after any invalidations.

Politics on Our Side

New Mexico & Utah: Two more states have legalized marriage equality through judicial action, bringing the total to 18. That's twice as many as last year! The 10th Circuit Court denied an appeal from Utah to deny samesex marriage. State officials are now appealing to the U.S. Supreme Court.

Pennsylvania: A U.S. court will address marriage equality in the state on June 9, 2014.

United States: The ban on organ transplants between HIV-positive people is now legal after President Obama has signed the bill into law. The HIV Organ Policy Equity Act (HOPE) ends a decades-long federal ban on allowing donated HIV-positive organs from being translated into HIV-positive patients.

United States: After opposition from conservative Southern states, same-sex spouses of National Guardsmen can now officially obtain benefits in any state.

United States: The 26 members of the Congressional Hispanic Caucus have come out in support of the Employment Non-Discrimination Act (ENDA). Last month, the Senate passed the bill by 64-32 votes, but House Speaker John Boehner (R-OH) refused to bring the bill to the lower chamber. Other Latino organizations that support ENDA include the Mexican American Legal Defense Fund, the League of United Latin American Citizens, and the Trans-Latina Coalition.

Northern Ireland: The lifting of the country's ban on adoptions by LGBT couples bodes well for the marriage equality movement.

Germany: President Joachim Gauck will not attend the Winter Olympics in Sochi in protest of human rights violations and the oppression of members of the opposition in Russia.

Tel Aviv: Israel has inaugurated its first memorial for the thousands of gays and lesbians persecuted by the Nazis during World War II. The memorial uses pink triangles like those identifying gays and lesbians in

German-occupied territory during the war. At least 15,000 were sent to concentration camps during the Holocaust because of their sexual identification, and more than half of them died. Nazi officials also used medical experiments

to make these people straight. Similar monuments are in Berlin, Amsterdam, Sydney, and San Francisco. Israeli President Shimon Peres has publicly backed marriage rights for same-sex couples.

Rome installed rainbow-themed lights at Christmas on a mile of Via del Corso, the city's main shopping street, to honor the memory of a gay teen who committed suicide and to fight homophobia.





Public High School Employs First Transgender Coach

After Stephen Alexander transitioned, he became the first openly transgender public high school coach in the country. Alexander coaches boys' soccer at Ponaganset High School in Gloucester (RI).

Schools Sued for Rejecting GSA, Not Protecting Students

The ACLU has sued a Lake County school district in Central Florida twice last year for refusing the formation of a Gay-Straight Alliance (GSA) club at the middle school. The first time was on behalf of Bayli Silberstein (right), then a 14-year-old eighth-grader, who had been blocked from forming a GSA for almost a year. Although the club met three times before the close of the school year, thanks to the lawsuit, students found the meetings difficult because of administrative monitoring attitudes.



New school rules passed in August required all existing clubs to reapply. Students led by 12-year-old Hannah Faughnan reapplied for a GSA in October. In December, the ACLU was told that the club had been denied because it was not an extension of the school curriculum. The ACLU reported that several other non-curricular clubs have been approved in the district.



The Southern Poverty Law Center is suing Moss Point School District (Jackson County, MS) for permitting anti-LGBT bullying. The suit was filed on behalf of lesbian Destin Holmes, who was even prevented from using the women's restrooms. Other LGBT students were also abused. An openly gay student attempted suicide after being physically attacked and called faggot, and a transgender student was frequently called "it" by both students and teachers. SPLC stated that the school district failed to take action although the organization demanded that they do so.

Courts Overturn LGBT Rights in India, Australia

Protesters gathered outside the Indian embassy in Washington to protest India's Supreme Court decision to reinstate a British Colonial era law criminalizing sodomy between consenting adults. The decision overturned a lower court ruling in 2009 declaring that the anti-sodomy law violated India's constitution. India's Parliament is to determine whether to repeal or retain the statute.

Protesters gathered about a statue of Mahatma Gandhi, who led the non-violent movement to achieve India's freedom from Great Britain.

It is estimated that 15 million LGBT people live in India.

LGBT couples lost the right to marry in Australia after its High Court overturned marriage equality laws. Wedding ceremonies already performed were invalidated.

New Zealand was the first—and only—Asia-Pacific country to legalize marriage equality.




People Who Make a Difference



At the end of last August, **Todd Gloria**, an openly gay man, became interim mayor of San Diego after the former mayor resigned in disgrace. From two military families, Gloria is Native Alaskan, Filipino, Dutch and Puerto Rican. His term is over on February 11, 2014 after the election of a permanent mayor.

In a hate crime, a 16-year-old bus rider lit the skirt of "agender"18-year-old **Sasha Fleischman** while he slept. Classmates, including **Ian Gonzer** (right), rose in support by wearing skirts to school. Mrs Dalloway's Bookstore announced that its staff would be wearing skirts on December 14 and that the store would donate 10 percent of purchases to Pacific Center, the oldest LGBTQ center in the Bay Area, if the buyer mentioned Sasha Fleischman. Oakland High School, where the attacker attended, honored Fleischman when varsity basketball team players wore
